

At the end of each communication session you will see:

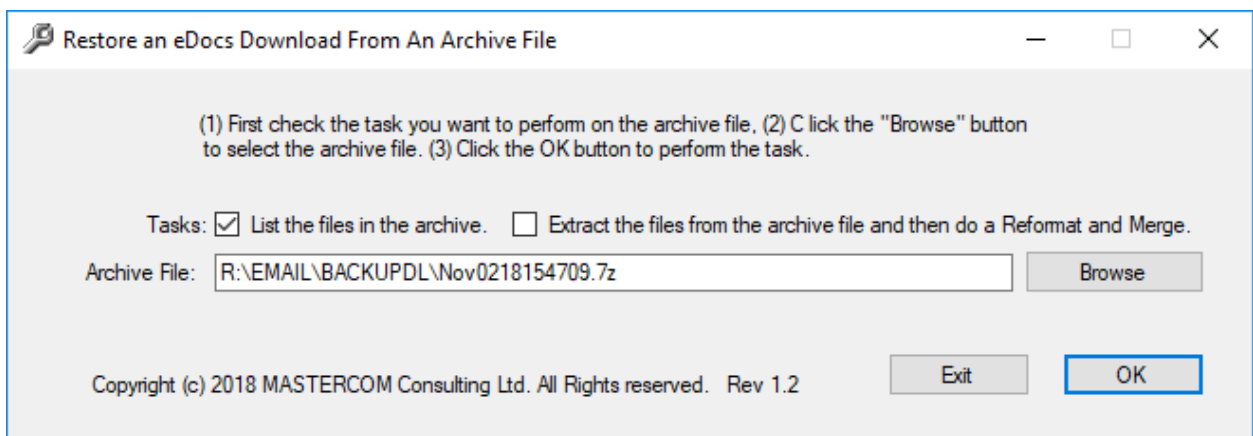

All zipped backups are found in the \EMAIL\BACKUPDL folder.

For example, explore to the \EMAIL\BACKUPDL folder and send the backup file that has the document you are referring to.

To examine a backup file

- 1) In the **MASTERCOM BrokerEDIPC E-Mail-EDI Engine .NET** program folder select the “**4 - Restore an eDocs Download**” program item.
- 2) Check the **Tasks:** checkbox – (List the files in the archive.)
- 3) Click the “**Browse**” button and explore to the \EMAIL\BACKUPDL folder the pick the zipped backup file, as illustrated below.
- 4) Click the “**OK**” button to list the files in the archive.
